## POWER 94.9/101.9 "WICKED MOVIE SCREENING RUN OF ENGAGEMENT (ROE) TEXT CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **POWER 94.9/101.9** "WICKED MOVIE SCREENING RUN OF ENGAGEMENT (ROE TEXT CONTEST" CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
