## POWER 94.9/101.9 "JUSTIN TIMBERLAKE TEXT CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **POWER 94.9/101.9 "JUSTIN TIMBERLAKE TEXT CONTEST" CONTEST CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.   - <u>Text/ON-Air</u>: Listen weekdays on or around 9:00 AM MT, 12:00 PM MT, 2:00 PM MT & 4:00 PM MT when the station gives the keyword Send a text message with the keyword spelled correctly to 801-570-0949 during the Contest Period. The keyword must be received by the :59 mark in the hour in which it was given. All entries must be received by 4:59 PM MT on January 17, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.
- 4. **Winner Selection.** On or about 8:00 AM MT each weekday during the contest period January 7 January 20, 2025 Station will select One (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within

- three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
